# **Guest Speaker:**

Nicholas (Nick) Drake was introduced as the Tucson representative of the Arizona Department of Veterans Services. After a few personal facts were shared, Nick got right into a myriad of programs that veterans may be able to use to their benefit. After revealing Arizona is ranked 15<sup>th</sup> in the nation for resident veterans, Nick spoke about: the Vet Center which was designed by Vietnam Vets; schooling (GI Bill) approved by Arizona; the three state veterans cemeteries; (continued on next page)

financial help (MIRF) up to \$20K per family for rent, child support, etc.; Veterans Standdowns, including an all female veteran standdown; help getting Honorary diplomas; Veteran Tool Kit for job \$'s; homeless veterans; the Be Connected App; small grant programs up to \$4,999 and large grants between \$5K to \$75K for 501c3 organizations; AZ Veteran license plates bring \$17 out of \$25 back into state vet programs.

After all of these comments, Nick entertained a wide range of questions. Our members showed their appreciation of Nick's willingness to share his knowledge with us.

A motion to adjourn was made by Bob Ozier at 1945 hours, seconded by Al Price and unanimously accepted.
